We the undersigned enter into this agreement with and fully understanding that:

1. The coverage of our wedding is assigned to Hayley Jansen trading as A Shot in the Dark Photography exclusively (hereafter called "The Photographer"). The coverage products are exclusively fixed to that stated above. A booking fee of \$300 is required to reserve and secure the date and hold the coverage price to that shown above, with the balance payable at least 4 weeks prior to the wedding. Payment can be made via cash, cheque and bank cheque made payable to A Shot in the Dark Photography.
2. Wedding dates and times listed with The Photographer are correct and Hair Dressers, Make-up Artists, Hire Cars and Caterers will be advised in respect to these. The Photographer will be notified immediately if any details of the wedding are changed.
3. Should a cancellation occur, The Photographer, will retain the booking fee but will honour, where dates are available, all monies paid for a period up to twelve (12) months from the wedding date allowing for postponement or deferral of the wedding.
4. The coverage time specified starts from arrival of The Photographer at the Brides House, or as previously arranged, and continues until the time agreed to in the above package.
5. Copyright of the images belongs to The Photographer. Any images taken by The Photographer may be used for advertising, publicity, general promotion, competitions, exhibitions, commercial enterprise or any other purposes thought fit and proper by The Photographer. All accolades and income generated through any of these endeavors remains the property of The Photographer. Whilst copyright privileges are given to us (the client) in issue of the images on disk, copyright remains with The Photographer.
6. In the circumstance where photographic coverage extends more than one (1) hour into the reception then a main meal will be provided for The Photographer at no cost to The Photographer.
7. All care and diligence will be exercised in the performance of the above assignment by The Photographer, however should; equipment failure, theft, accidents, photographer ill health, faulty materials, loss or damage to the photos in transit between The Photographer and laboratory or vice versa, loss or damage to the photos during civil disturbance, industrial disputes, or elements beyond the control of The Photographer occur, which prevents the performance, in whole or in part, of this agreement then liability is limited to the refund of any money paid under this agreement, excluding the deposit, which shall be full and final satisfaction of any damage or any loss suffered.
